Realizing that many real estate mediations involve emotions, Susan emphasizes two dimensions of mediation: the emotional dimension and the cognitive dimension. By allowing parties to feel heard, she is able to maneuver through emotions so that the cognitive dimension may involve objective, fact-based negotiation in an efficient manner. Susan brings to the table patience, perseverance, perpetual optimism, and past experience since 1998.
