FEES:

\$350 per hour, including 2+ flex time hours of prep time, reasonable extra advisement hours, travel time and arranging a mutually-convenient place for the hearing, or via on-line virtual Zoom sessions. Additional hourly fees may be charged to participants who cause excessive delays or require more detailed research, at the discretion of the Mediator. This seldom happens, but any additional potential charges will be discussed on a "case-by-case" basis with the appropriate party. Most of Craigs hearings are resolved within the initial 3 hour period charged by the CAR Mediation Center's "Fees & Costs" summary, which are typically far less than Arbitration or Litigation costs.
