His experience includes disputes involving such issues as the allocation of responsibility for repairs, breach of express warranty, scope of easements, return of deposit, remedial work, environmental damage responsibility, entitlement to broker's fee, satisfaction of closing conditions for release of escrow, developer/landowner disputes, lease agreements and, in general, the interpretation of relevant real estate transfer, financing and related documents. He has been certified by the Family Firm Institute as a Family Business Advisor. From 2015 to 2017 Mr. Lutringer deepened his knowledge of land use regulatory and CEQA matters while serving as a member of a Municipal Advisory Council for the San Bernardino County Board of Supervisors, He has authored articles and presented workshops to professional organizations on aspects of mediation (e.g., the American Bar Association, the Association for Conflict Resolution, the Desert Bar Association, the Southern California Mediation Association, and to panels of court-appointed mediators in Riverside County. ## **STATEMENT**

The goal of a consumer-related real estate mediation is to achieve a mutually agreed settlement as expeditiously as possible. As a mediator, Mr. Lutringer listens carefully to each side in joint session and private caucus and reviews any relevant documents in order to understand the position of each party and help the parties understand each other. His philosophy is to encourage disputing parties to use their best commercial sense to see the possible weaknesses of their own position and the strengths of the other side's position and from that basis, try to find agreement, keeping in mind, the inherent risks of litigation or arbitration as well as the potential significant monetary and other costs of not reaching settlement. In rare instances and at the request of both parties engaged in mediation who, despite diligent efforts, have been unable to overcome an impasse, Mr. Lutringer will make a mediator's proposal to bridge the divide.
