

SFR/ABR® 2010 Rebate Information

C.A.R. members who purchase and complete NAR's Accredited Buyer's Representative (ABR®) Designation Core Course and NAR's "Short Sales and Foreclosures (SFR): What Real Estate Professionals Need to Know" course are eligible to receive a rebate on the purchase price of the SFR course (up to the purchase price or \$99, whichever is less).

TERMS AND CONDITIONS

- C.A.R. members must purchase, complete and pass the final exam for the ABR® designation core course offered by C.A.R. during the period of 1/1/09 through 3/31/10.
