Treasurer James Liptak, Chair of the Strategic Planning and Finance Committee, presented the 2008 - 2010 Strategic Plan and the 2008 Annual Budget, including the proposed program augmentations.

Strategic Plan and Budget

Proposed Program Augmentations

- CALIFORNIA REALTOR® EXPO: Consumer Homebuyer's Fair
- REALTOR® Advertising: Hispanic Campaign
- Forms Compliance Advisor
- Membership Development: Market Opportunity Conferences
- Communications: Enhanced Video/Online/General Content
- Local Association Services: Strategies for the New Millennium Conferences
- Local Association Services: AE Institute
- Local Association Services: Leadership Academy

It was Moved by James Liptak and Seconded to approve a 2008-2010 strategic plan and 2008 budget with the following criteria:

- a. C.A.R. Revenue \$30,485,600
C.A.R. Cost \$27,655,300
Net Surplus \$2,830,300
- b. Political Activities Fund Revenue \$1,604,000
- c. Issues Action Fund Revenue \$1,604,000
Issues Action Fund Transfer to IMPAC \$689,200
- d. 116 budgeted C.A.R. staff positions
- e. Membership dues, including \$115 for operating programs, \$10 for the Political Activities Fund and \$10 for the Issues Action Fund, are set at a total of \$135 per member (predicated on 2008 ear end membership of 172,200)
- f. New member fee be set as \$100 per new member.
- g. A 2008 Capital Budget (funded with Association reserves) totaling \$146,400

Executive Committee Member Steve White requested that the question be divided so that item f. could be discussed separately. There was no objection.

A vote on the main motion, excluding item f., CARRIED.

Action of Directors: Pending

A vote on item f., that the new member fee be set as \$100 per new member, CARRIED.

Action of Directors: Pending

It was Moved by James Liptak, Seconded, and CARRIED to approve for members in areas not serviced by local associations an additional \$30 in membership dues. This amount would be in excess of the dues approved for members coming through the local associations.

Action of Directors: Pending

It was Moved by James Liptak, Seconded and CARRIED, that \$360,000 be approved for an additional 4 percent pension contribution to the C.A.R. and REBS employee pension plan for 2007, augmenting the previously approved budget of ten percent.

Action of Directors: Pending

It was Moved by James Liptak, Seconded and CARRIED, that \$100,000 be approved to conduct consumer research to determine possible features of a consumer website.

Action of Directors: Pending

It was Moved by James Liptak, Seconded and CARRIED, to approve a budget augmentation to develop and promote a commercial website for REALTOR® members who practice commercial real estate with a total revenue of \$28,800, total expenses of \$14,200 and a capital budget of \$5,000.

Action of Directors: Pending

There being no further business, the meeting was adjourned at 2:37 p.m.
