PROFESSIONAL EXPERIENCE

Jean-Paul Menard is an attorney and mediator. Mr. Menard has over 40 years of legal experience, including twelve years as a partner in a national law firm. Most recently, Mr. Menard was a partner with the law firm of Brown White & Osborn LLP, in Los Angeles, from February 2019 to March 2025, when he retired from his law practice to mediate on a full-time basis. During his legal practice, Mr. Menard litigated a wide variety of cases involving real estate purchase transactions, landlord-tenant disputes, quiet title and real estate partition actions, homeowner association issues, breach of contract claims, and other business-related disputes. Mr. Menard's legal practice also included negotiating and documenting business and commercial agreements. Mr. Menard began his mediation practice in 2008. Since then, he has mediated over 1000 cases involving residential and commercial real estate transactions, general business, commercial, and employment related disputes. Mr. Menard has been a C.A.R. mediation panelist and a mediator for the United States District Court, Central District of California, since 2014; and a panel mediator for the American Arbitration Association since 2019. Mr. Menard was a mediation panelist for the Los Angeles County Superior Court's Alternative Dispute Resolution program from 2008 until the program was terminated in 2013, and a mediation panelist for the California Academy of Mediation Professionals in 2013-2014. Mr. Menard is certified by the Los Angeles County Bar Association to conduct mediations.

STATEMENT

I'm a firm believer that mediation is the most cost-effective and efficient method to resolve disputes. When mediating cases, I'm very persistent, creative, and proactive. Given my extensive litigation background and knowledge of real estate law, I'm able to quickly identify the relevant factual and legal issues in each case. I evaluate the strengths and weaknesses of each party's position. I explore the parties' interests and desires. I problem solve with the parties and offer practical, sound solutions to achieve a settlement. If I'm unable to settle a dispute during the mediation session, I'll follow through with the parties in a further effort to resolve the matter.

FEES:

\$375/hour

The Parties agree to pay the Mr. Menard's fees and expenses as invoiced based on a \$200 rate for the first two hours of mediation time, and a rate of \$375 for additional mediation time. Mr. Menard charges a half-day minimum mediation flat fee rate of \$1,900, which includes four hours of mediation time (at the above rates) and four hours of preparation time. Preparation time includes administrative tasks, all pre-mediation communications with the parties and review of mediation statements and documents. The full-day minimum mediation flat fee rate of \$3,400 includes seven hours of mediation time and five hours of preparation time. Any additional mediation or preparation time is invoiced at the rate of \$375 an hour. Fees for any unused time will not be refunded. A flat rate travel fee of \$500 is charged for travel within Los Angeles and Orange counties. Parties are responsible for mediation related expenses, which may include mediation facility fees for in person mediations. Invoices must be paid within five days of the Invoice date. Mr. Menard reserves the right to cancel or continue the Mediation to another date if full payment is not timely received.

SERVICE AREAS

Mr. Menard is available to conduct Zoom mediations to resolve disputes pending in any county throughout California. Mr. Menard's service area for in-person mediations is Los Angeles and Orange Counties. Mr. Menard will travel to the parties' location within these counties for a \$500 flat travel fee.
