PROFESSIONAL EXPERIENCE

Gary Weiner is an internationally recognized mediator and leader in mediation scholarship. He was the Chair of the ABA Mediation Research Task Force and has lectured throughout California and in Australia on the state of empirical data regarding mediator behavior. His seminal paper, A Call for Evidence Based Standards of Mediation Quality, has been read by scholars and practitioners all over the world. Gary Weiner has taught mediation to attorneys, other professionals and consulted with the High Courts of Mumbai and New Delhi, training new mediators there. He has presented programs on mediation, mediation advocacy and mediation research for large firms and bar associations all over the country and in India and Australia.

He served for 4 ½ years as Director of the Office of Alternative Dispute Resolution of the Sonoma County Superior Court and as Mediation Program Administrator of the Mediation Program at the California Court of Appeal in San Francisco.

Gary Weiner has had a general trial and litigation practice from 1983 through the present except for the periods during which he was employed by the Court, representing both plaintiffs and defendants.

STATEMENT

I have devoted the majority of my professional time to the practice, teaching, promotion and study of mediation since the late 1980s when I realized that the adversarial system for resolving civil disputes frequently caused more harm than good. I came to this conclusion because my clients were everyday people caught up in problems that they could not solve alone. They were baffled, frustrated

and anguished by their experience as litigants and I knew there had to be a better way. Mediation is the best method I've seen yet to help people understand the nature of the problems that they share and to reach resolution through the often difficult work of coming to terms with the reality of conflict and the need to acknowledge that there's a solution available that can work better for everyone than almost anything the court can impose.
