TELEMARKETING REGULATIONS

- ☐ The Federal Communications Commission ("FCC") rules
- ☐ The Federal Trade Commission ("FTC") rules
- ☐ California Business & Professions Code Sections 17590-17594
- California Public Utilities Code Sections 2871-2876



PROCEDURE TO FOLLOW



- ☐ You have a **written policy**, available upon demand, for maintaining a do-not-call list.
- ☐ You **train** all engaged in telemarketing on the existence and use of the do-not-call list.
- ☐ You **provide the identity** of the name, telephone number and address of the person or entity on whose behalf the call is being made.
- ☐ You **record/maintain** requests not to be called on a company-specific donot-call list within 30 days of request. Such list must be maintained and honored for 5 years.

SPECIAL PROHIBITIONS

- ☐ Call only during **reasonable hours**: no calls before 8 a.m. or after 9 p.m. (local time at the called party's location).
- □ Do not disconnect an unanswered call prior to at least 15 seconds or four rings (excluding wireless phones).
- ☐ No deceptive and abusive telemarketing acts or practices.
- ☐ No calling those on the Do-Not-Call list!



DO-NOT-CALL EXCEPTIONS

Calls Okay If:

- □ Written Permission
- ☐ Established Business Relationship
- ☐ Personal Relationship
- ☐ Tax-Exempt Nonprofit Organizations



Exceptions DO NOT apply if the recipient has requested not to be called!

DO-NOT-CALL SAFE HARBOR

Make a mistake and call someone on the Do-Not-Call list? Forgiven if:

- ☐ Procedures followed (see prior slides).
- ☐ You maintain and record a list of telephone numbers that may not be contacted.
- ☐ You have a documented process to prevent calls to those on donot-call list (use an official version of the national do-not-call registry obtained no more than 31 days prior to the date any call is made).

USE OF NATIONAL DO-NOT-CALL DATABASE

- ☐ The Do-Not-Call database may not be used for any purpose other than compliance with state and federal law
- ☐ The cost of accessing the Do-Not-Call database may not be shared with other companies
- ☐ The National Do Not Call Registry List can be obtained here: https://telemarketing.donotcall.gov/



ROBO CALLS (AUTOMATED CALLS)

- ☐ No robocalls without express written consent
- ☐ Robocalls must be made between 9 a.m. and 9 p.m.
- ☐ Robocalls must be introduced by a live person
- ☐ Person called must give consent to hear recorded message
