C.A.R. Education Foundation Raffle Official Rules

- 1. How and When to Purchase:** Raffle tickets available for sale from April 30, 2018 through 11 a.m. on October 13, 2018 or until tickets are sold out ("Raffle Period"). Raffle tickets are \$20 each or six (6) for \$100, and may be purchased with cash, check or credit card. To purchase tickets, contact a C.A.R. Education Foundation Director, or call the C.A.R. Staff Education Foundation Liaison at (213) 739-8217. All tickets purchased during the Raffle Period will be entered into a drawing on October 13, 2018 at the Fall C.A.R. Board of Directors meeting in Long Beach, California.
- 2. Eligibility:** Ticket purchasers and winners must be 18 years of age or older and residents of the United States. Only one name may be entered per ticket. You may buy as many available tickets as you wish. All ticket purchases are final and non-refundable. Directors of the C.A.R. Education Foundation and employees of C.A.R. and its subsidiaries are ineligible.
- 3. Prize; Odds of Winning:** One (1) prize will be awarded: A \$4,000 travel voucher from All Celebrity Travel, Inc. which must be redeemed through All Celebrity Travel, Inc. as provided in these Official Rules. Estimated retail value is \$4,000. Prize not redeemable for cash; no substitutions. Tickets are non-refundable. Education Foundation will use commercially reasonable efforts to attempt to contact the winner by the contact information provided on the ticket stub. If the winner is not reached within a reasonable period or if the winner is ineligible under these rules or applicable law, that person will not be awarded the prize, and an alternate winner will be chosen at random from all other entries. If no eligible winner is found and contacted after five draws, the C.A.R. Education Foundation has the option at its sole discretion to not choose an alternate winner, and may choose not to award the prize.
