Laura also teaches the theory and practice of mediation in addition to courses on effective communication strategies, diversity and inclusion. In addition, she is the mentor for the National Conflict Resolution Center's Mediator Credential Program working with aspiring mediators in a program that qualifies them for the San Diego Superior Court Civil Mediation Panel. STATEMENT
